Update of Accreditation Progress

In the Accreditation update that was circulated in April, 2010 the plan on how our agency would be moving forward towards our validation for the fall of 2011 was shared. The first part of the plan was to have all Gaps in the Domains identified and Action Plans developed to address the Gaps by June 2010. To reach this goal both committees were committed to meeting twice a month.

The committees are happy to report to you that ALL Gaps in the Domains (excluding the Inclusive &Flexible Services) have been identified and Action Plans are developed with some Domains completed.

The second phase of moving forward is to have ALL Domain Action Plans completed by November 2010. As of September the committees have regrouped and continue to meet twice a month focusing on the development of the Action Plans.

The third goal is to start 2011 off with introducing the changes to the agency that have resulted in filling the GAPS. The final goal will be submitting all data addressing the Domains to FOCUS. This will be done on April 29th/2011. After this point the organization will prepare for our onsite Validation that will be taking place in the fall of 2011.

Below is a list of the Inclusive and Flexible Services Domains. I have also indicated beside each what stage they are at in the Accreditation process.
