The successful candidate will work co-operatively with the Director of Client Services in providing a comprehensive health care program and providing supports and services to individuals with developmental disabilities as well as assist with training of caregivers, families and community agencies as required. To provide a range of clinical services. To provide support, supervision and guidance to the Centre's employees with respect to Occupational Health matters. To provide support to allied health professionals associated with the Centre.
